

Frequent Values by Entertainment™ Terms and Conditions of Use

1. General

1.1. Go to the NRMA application (NRMA App) and select a dining offer by clicking “Redeem Offer”. You will then be provided with a virtual voucher (“Frequent Values Voucher”).

1.2. Show your Frequent Flyers Voucher via the NRMA App at participating restaurants to obtain your benefit.

2. Dining Out
